VIACK

Tim Dotson reported that Video Teleconferencing is now being used in all localities which requires six phone lines and is expensive for each locality.

The Commission has purchased enough equipment for all localities to switch from doing Video Teleconferencing using ISDN lines to Internet-Based VIACK System. The equipment was purchased at a cost of \$13,000.00. The yearly cost of operating the VTC units using ISDN lines is approximately \$35,000.00 total per year for all localities. The estimated cost of the VIACK System will be \$5,000.00 per year total. The new program should be operational by July 1st.

Budget Amendment
